[Chapter 2] In 2018, lawyers will be anticipating and planning for the post-2018 repeal of the alimony tax deduction, effective December 31, 2018. Pre-2019 divorce instruments will preserve the alimony tax deduction, even for most post-2018 modifications. Family lawyers will have to adapt their strategies. [Chapters 3 & 4] An increased standard deduction and child tax credit might (in some, but not all, cases) make up for the suspension of personal and dependency exemptions and miscellaneous itemized deductions for tax years 2018 through 2025.
